Facials/Treatments:

If you are pregnant, have a pacemaker (or any implanted device), have a cardiac condition, have epilepsy or cancer, you cannot receive ultrasonic treatments in your facial.

If you have any active, communicable, untreated, topical infections or conditions on areas to be worked on (such as cold sores, pink eye, impetigo, ring worm, warts, etc..) these conditions must be healed (no longer actively infectious or spreadable) before receiving a facial/treatment.

If you are prone to cold sores, we recommend using cold sore medication several days prior to your facial/treatment and several days after.

LED

Please note that if you have epilepsy (or have seizures), have light sensitivity or are photo-allergic, or are taking any medication that causes light sensitivity, if you get migraines triggered by light, have skin cancer or any undiagnosed suspicious moles or lesions, or if you are pregnant, you should not receive an LED treatment.

If you are prone to cold sores, you must use cold sore medication several days prior to your LED treatment and several days after.

Lymphatic Drainage

If you have any acute inflammation, malignant tumors, serious heart issues, serious kidney issues, bronchial asthma, thyroid issues, oedema, thrombosis, are undergoing chemotherapy/radiation therapy, are pregnant or are ill (cold, flu, fever, etc), you should not receive lymphatic drainage. **Initial** _____

HydraFacial

If you are allergic to shellfish, honey, or aspirin, have severe rosacea, have significant telangiectasia (dilated capillaries), are taking Accutane, have received cosmetic facial injections less than two weeks ago, have red or raised bumps or other unidentifiable skin issues, have an autoimmune disease, or are pregnant or nursing, you should not receive a HydraFacial.

If you are prone to cold sores, you must use cold sore medication several days prior to your HydraFacial treatment and several days after.

Body Wraps

If you have serious heat sensitivities, nerve damage that interferes with the ability to sense heat, a serious heart condition, a pacemaker, a serious kidney condition, a serious thyroid condition, uncontrolled high or low blood pressure, diabetes requiring insulin, cancer, are receiving chemotherapy/radiation therapy, have impaired circulation, rheumatoid arthritis, open wounds, chronic skin conditions, varicose veins, are ill (cold, flu, fever), are pregnant or have claustrophobia, you should not receive a body wrap.
